2. To Change the Composition of Board of Directors and amend the Article No. 50 (8) of the Articles of Association of the Company.

To consider and if thought fit, to pass with or without modification(s), the following Resolutions as a Special Resolution:

"RESOLVED THAT pursuant to the provisions of Section 14 and other applicable provisions, if any, of the Companies Act, 2013, including any statutory modification or re-enactment thereof for the time being in force and the Rules framed there under, as amended from time to time and subject to approval of the Central Government, and/or of any other statutory or regulatory authority, as may be necessary, Article 50 (8) of Articles of Association of the Corporation be substituted by the following New Article 50(8) to read as under:

#### **EXPLANATORY STATEMENT**

The following Explanatory Statement, as required under Section 102 of the Companies Act, 2013, set out all material facts relating to the special business the accompanying Notice.

#### ITEM NO: 1

The authority of the Board was limited to Rs. 20.00 lac was fixed in respect of expenditures concerning works of Capital nature as specified in Article 54(2) of the Articles of Association of the Corporation since incorporation of the Corporation (in the year 1997). Beyond the aforesaid amount, a special budget involving expenditure on acquisition of fixed assets other than the replacement of existing assets and assets is to be submitted to Administrative Department for obtaining prior approval of Government.

Since there has been inflation over the years and the cost /price has increased manifold over the years, there is a need to revise the aforesaid monetary limit to Rs. 500 lacs. The proposed increase of monetary limit from Rs.20 lacs to Rs. 500 lacs require alteration of Articles of Association {Article-54(2)} of the Corporation.

The alteration of Articles of Association of the Corporation requires approval of members by special resolution pursuant to Section 14 of the Companies Act, 2013.
