a) Trust Fund

Scholarship Screening Committee meeting for awarding scholarship for 2nd and 3rd quarter of academic year 2011-12 to students with disabilities under scholarship scheme (Trust Fund) held on 24.4.2012 at Ministry of SJ&E conference room, Shastri Bhawan, New Delhi. Scholarship has been awarded to 379 students (286 male & 93 female) for a total sum amounting to Rs. 2,02,27,399/- (i.e. Rs. 1,99,10,200 towards scholarship to 379 students and Rs. 3,17,199/- towards Assistive Devices to 4 (four) students.

b) National Fund

Rs. 66,64,524/- has already been awarded towards scholarship to 492 applicants and 11 renewal cases under National Fund scheme for students with disabilities was awarded for the academic year 2011-12.
