1. EQUITY SUPPORT FROM GOI

2. SANCTION OF LOANS

During the month of August, 2019, the Corporation has sanctioned Rs. 1533.52 lakh for the benefit of 1487 Persons with Disabilities (Divyangjan).

3. RELEASE OF LOANS

During the month of August, 2019, the Corporation has released Rs.1502.15 lakh for the benefit of 1487 Persons with Disabilities (Divyangjan).

4. SANCTION OF GRANTS FOR EDP/SKILL TRAINING

During the month of August, 2019, the Corporation has not sanctioned any Grant for EDP/Skill Training of Persons with Disabilities (Divyangjan).

5. RELEASE OF GRANTS FOR EDP/SKILL TRAINING

During the month of August, 2019, the Corporation released EDP Grants of Rs.34,32,500/- to 3 (Three) organizations for skill training of 650 PwDs.

6. DISTRIBUTION OF TOOLKIT

On 29th August, 2019, Twenty (20) Tablets were distributed to PwDs trained in Basic Computer Course and Ten (10) Mobile Repairing Kits were provided to PwDs trained in repairing of Mobile Handset. These PwDs were trained at the Skill Training Centre of the Corporation at Faridabad (Haryana) under CSR funds received from PTC Foundation.

7. REGISTRATION OF NHFDC FOUNDATION

NHFDC Foundation was registered by the Corporation as Public Trust to carry out CSR activities of NHFDC and other PSUs/Companies. NHFDC Foundation Trust Deed was signed on 29th August, 2019.

8. SWACHHTA PAKHWADA

NHFDC organized Swachhta Pakhwada from 16th to 31st August, 2019 at its Registered Office at Faridabad (Haryana) and Corporate Office at Okhla, New Delhi.

9. IMPORTANT MEETINGS, PROGRAMS ETC.

Following important meetings were held during the month of August, 2019:-

a) Meeting with MD, NBCFDC (14th August, 2019)

A meeting was held between CMD, NHFDC and MD, NBCFDC at New Delhi on Concessional loan schemes of both the corporation for the respective target groups were discussed during the meeting.

b) Meeting with Joint Director, Institutional Finance, Uttar Pradesh (20th August, 2019)

A meeting was held between CMD, NHFDC and Joint Director, Institutional Finance and 5 RRBs of the state at Lucknow (Uttar Pradesh) on 20th August, 2019 regarding implementation of NHFDC scheme in Uttar Pradesh.

c) Job Fair for PwDs, Chennai, Tamil Nadu (25th August, 2019)

A Job Fair for Persons with Disabilities was held at Chennai, Tamil Nadu on 25th August, 2019. Manager (S&P), NHFDC attended the Job Fair on behalf of the Corporation.

d) Meeting with Officials of TNSAC Bank at Chennai (26th August, 2019)

A meeting was held at Chennai, Tamil Nadu between Manager (S&P), NHFDC and officials of Tamil Nadu State Apex Cooperative Bank Ltd. (SCA of NHFDC) to discuss and resolve issues concerning utilization details of NHFDC funds.

e) Meeting with officials of RSFDC at Jaipur (28th & 29th August, 2019)
