

Major activities/decisions taken for the month of December, 2010.

1. Meeting of Board of Directors

63rd meeting of Board of Directors of the Corporation was held on 6th December, 2010 and following major decisions had been taken at the said meeting.

a) Release of Advance Funds to State Channelising Agencies:

Issues concerning bottlenecks in increasing disbursement of loan for benefit of the target group (persons with disabilities) were discussed. In order to quicken & simplify availing funds for the target group, It was decided to release funds in advance (upto 50% of the notional allocation made to the state / U.T.) to good performing State Channelising Agencies.

b) Loan for Professional/Educational/Training courses : Bring the scheme in line with SBI Education Loan Scheme

The loan scheme of the Corporation for Professional/ Educational/ Training courses to disabled persons was amended to bring the same in line with SBI Education Loan Scheme except in respect of matters concerning;

- eligibility criteria
- rate of interest
- rebate for women beneficiaries
- repayment period and
- procedure for obtaining loan.

The aforesaid modification would not only assist the beneficiaries in terms of higher loan amount, but would also entitle beneficiaries fulfilling the eligibility criteria (under Central Scheme of Ministry of Human Resources Development) to apply /obtain the benefit of interest subsidy during moratorium period.

c) Constitution of Remuneration Committee

The Remuneration Committee was re-constituted.

2. Sanction and Disbursement of Loans
