2. SANCTION OF LOANS

During the month of January, 2020, the Corporation has sanctioned Rs. 1029.50 lakh for the benefit of 998 Persons with Disabilities (Divyangjan).

3. RELEASE OF LOANS FOR BENEFIT OF DIVYANGJANS

During the month of January, 2020 the Corporation has released Rs. 1029.99 lakh for the benefit of 998 Persons with Disabilities (Divyangjan).

4. RELEASE OF GRANTS FOR EDP/SKILL TRAINING

During the month of January, 2020, the Corporation released grant of Rs. 21.70 Lakh Grant for EDP/Skill Training of 320 Persons with Disabilities (Divyangjan).

5. AWARENESS CAMP/EXHIBITIONS/FAIRS

During the month of January, 2020 the Corporation participated in the following events for creation of awareness and disseminated information concerning NHFDC schemes for the benefit of Persons with Disabilities (Divyangjan):-

i) 11th January, 2020 : Job Fair for PwDs at Faridabad

The Corporation organized a job fair for PwDs at Faridabad (Haryana) alongside the distribution camp (Assistive devices) organized by ALIMCO.

ii) 25th January, 2020 : Swadeshi Mela at Balia, Uttar Pradesh

The Corporation participated in Swadeshi Mela at Satish Chandra Mahavidyalaya Maidan, Balia, Uttar Pradesh and disseminated information concerning NHFDC schemes for the benefit of PwDs.

a) Meeting with SCAs of NHFDC at New Delhi (3th Jan., 2020)

A conference of implementing agencies of the Corporation was organized at India Habitat Centre, Habitat World, Lodhi Road, New Delhi. At the said conference, implementation of NHFDC schemes was reviewed and issues concerning thereto discussed in detail at the meeting. In addition, incentives were released to implementing agencies based on their performances/achievements, as per policy of the Corporation.

b) Signing of MoU with National Film Development Corporation at New Delhi (7th Jan., 2020)

A Memorandum of Understanding was signed between the Corporation and National Film Development Corporation at New Delhi regarding skill training of Divyangjan.

c) Brief of standing committee on skill training at Parliament Annexe (7th Jan., 2020)

d) Meeting with the officials of RSFDC, Rajasthan at Jaipur (16th Jan., 2020)

A meeting was held between CMD, NHFDC with officials of RSFDC concerning implementation of NHFDC Schemes in the state.

e) Meeting with the officials of State Livelihood Mission at Jaipur (16th Jan., 2020)

A meeting was held between DGM(Project) and officials of State Livelihood Mission (SLM), Rajasthan on 16th January, 2020 concerning implementation of NHFDC Schemes in the state through SLM.
