a) National Workshop for Skill Development at New Delhi on 03.07.2018

Official of the Corporation participated in National Workshop for Skill Development, organized by DEPwD, MSJE on 03.07.2018 in Hall No.06, Vigyan Bhawan, New Delhi

b) National Summit and Loan Mela organized by NIEPMD at Chennai
