3. **MEETING OF BOARD OF DIRECTORS**

69th meeting of Board of Directors of the Corporation was held on 25th June, 2012 at New Delhi and major decisions taken at the said meeting are as under:

a) Tripartite Agreement involving the Corporation, ALIMCO, Kanpur and Person with Disability

CMD was authorised to enter into tripartite agreement involving the Corporation, ALIMCO, Kanpur / other PSEs engaged in manufacturing, production and fabrication of commercial products and marketing of the same and the Beneficiary (Person with Disabilities) for extending assistance to Persons with Disabilities for setting up income generating activities.

b) Removal of Income Criteria as one of the eligibility conditions for availing loan assistance from NHFDC

Approval of the Board was accorded for waiver of 'Income Criteria' as one of the conditions of eligibility for NHFDC assistance.

c) Scheme of financing assistive devices

Approval of the Board was accorded for providing assistance for procurement of assistive devices to help persons with disabilities in terms of enhanced economic opportunity and improve self-employment prospects /employability under a special scheme approved for the purpose.

d) **Collaboration with National Trust, M/o. SJ&E, GoI for implementation of schemes of the corporation**

Collaborative arrangement with National Trust, M/o. SJ&E,GoI was approved wherein National Trust was to function as channelizing agency of this corporation (NHFDC) for extending assistance to Persons with Disabilities through Association for Rehabilitation under National Trust Initiative for Marketing (ARUNIM) under the aegis of National Trust.

4. **MEETINGS/WORKSHPS**

a) 8th June, 2012

A meeting of Town Official Language Implementation Committee was held on 8th June, 2012 at NHPC Office Complex, Faridabad. Representative of the Corporation attended the meeting.

b) 12th June, 2012

i) A review meeting of progress made by 10 (Ten) Regional Rural Banks (RRBs) of Uttar Pradesh in implementation of NHFDC schemes (under credit Guarantee Scheme) was convened by Principal Secretary, Viklang Kalyan, Uttar Pradesh on 12.6.2012 at Lucknow. CMD, NHFDC attended the meeting.
