During the month of June, 2019, the Corporation has sanctioned Rs. 456.00 lakh for the benefit of 453 Persons with Disabilities (Divyangjan).

6. IMPORTANT MEETINGS, PROGRAMS ETC.

Following important meetings were held during the month of June, 2019:-

a) Meeting with NGO-HAVAN (7th June, 2019)

A meeting was held with representative of Harmonious & Voluntary Action for Needy (HAVAN) – NGO regarding tie up for Skill Training.

b) Meeting for concessional loans to PwDs for Water, Sanitation & Hygiene (12th June, 2019)

A meeting was held with UNICEF, Water.org, NBFC – MFIs regarding concessional loans to PwDs for water, sanitation and hygiene (WASH), developing inclusive toilets, safe drinking water facility at New Delhi. CMD, NHFDC alongwith officials of the Corporation attended the meeting.

c) Meeting with Principal Secretary, Govt. of Delhi (13th June, 2019)

A meeting was held between CMD, NHFDC and Principal Secretary, Department for the Welfare of SC/ST/Minorities, Government of NCT of Delhi at Delhi Secretariat, New Delhi regarding implementation of NHFDC schemes in Delhi.

d) Meeting with VRCH, Delhi regarding Job Fair (13th June, 2019)

f) Meeting with Additional Chief Secretary, Social Welfare, Govt. of Assam (20th June, 2019)

g) Meeting with CMD, NEDFi (20th June, 2019)
