

Major activities/decisions taken for the month of March, 2011.

1. MEETING OF BOARD OF DIRECTORS

It has been decided that 65th meeting of Board of Directors of the Corporation be held on 21st April, 2011.

2. SANCTION OF LOANS

- iii) Meeting between CMD, NHFDC with Shri P.K. Biswas, Chief General Manager, NSIC – Technical Service Centre regarding EDP training.
- iv) Meeting between CMD, NHFDC with Shri P.S. Paul, DGM, Union Bank of India for implementing NHFDC schemes through bank.

4. NATIONAL SCHOLARSHIP SCHEME: MEETING OF SCHOLARSHIP COMMITTEE

A meeting of Scholarship Committee was held on 22.3.2011 at Shastri Bhawan, New Delhi under the Chairmanship of Economic Adviser, Ministry of S.J.&E., GOI to decide about additional scholarships to be awarded to students with disabilities for the financial year 2009-10, in addition to 284 students who have already been awarded.

A meeting of CMD, NHFDC with all HODs of all divisions was held on 30th March, 2011 regarding implementation of NHFDC schemes through Nationalized banks.
- iv) Quarterly Meeting of Raj Bhasha Implementation Committee
A meeting of Raj Bhasha Karyanwayan Samiti of NHFDC was held on 31st March, 2011 to discuss implementation of Official Language in the Corporation.

6. Workshop at Panaji (Goa):

A workshop had been organised in Panaji, Goa with assistance of NHFDC to Goa State Scheduled Caste and OBC Finance Development Corporation Limited (SCA of NHFDC in Goa) on 14th March, 2011 for creation of awareness about NHFDC schemes for benefit of persons with disabilities.

7. EDP TRAINING FOR PERSONS WITH DISABILITIES

- a) Sanction
The Corporation sanctioned Rs. 2.40 lac for two EDP training programme for imparting training to **40 persons with disabilities** on 'Advance Swing Machine Operator course' through AEPC Rural Dev. & Labour Welfare Foundation at Malleshwaram and Audugodi, **Bangalore**.
- b) Disbursement
The Corporation released **Rs. 34,500/-** towards stipend to 25 trainees in respect of training on 'Swing Machine Operator course' at ATDC Ballabgharh, Faridabad (Haryana).

8. CHANGEOVER FROM IS/ISO 9001:2000 TO IS/ISO 9001:2008

The Bureau of Indian Standards (BIS) has conveyed to the Corporation about its consent for Switchover of Quality Management System Licence from IS/ISO 9001:2000 to IS/ISO 9001:2008 w.e.f. 09-03-2011.
