4. PROJECT SCREENING COMMITTEE MEETING

A meeting of Project Screening Committee of the Corporation was held on 19th May, 2015. At the said meeting project proposals involving NHFDC's share of Rs. 231.88 Lacs were sanctioned for the benefit of 31 PwDs.

5. SKILL & EDP TRAINING FOR PWDs

During the month of May, 2015 the corporation sanctioned Rs. 37.80 Lac for training of 330 PwDs under its scheme of Financial assistance for Skill & Entrepreneurial Development for 11 programs.

6. SCHOLARSHIPS

a) Trust Fund Scholarship Scheme

At the meeting of Scholarship Screening Committee (Trust Fund) held on 27.05.2015, scholarships were sanctioned for 3rd Qtr (01.01.2015 to 31.03.2015) to **704 (510 Fresh +194 renewal)** students with disabilities involving aggregate amount of **Rs. 4.26 Crore.**

b) National Fund Scholarship Scheme

At the meeting of Scholarship Sanctioning Committee (SSC) held on 15.05.2015, **517** Scholarships (**500 Fresh & 17 renewal**) were sanctioned to students with disabilities involving aggregated amount of **Rs.56.29 lakh** for the academic year 2014-15.

i) Mega Camp at Raisen Vidhisha, Madhya Pradesh on 2nd May, 2015

NHFDC facilitated distribution of selection letters for skill training of PwDs at the Camp.
