1. Vigilance Awareness Week

4. Scholarship to Students with Disabilities 2011-12

a) Scholarship Scheme (Trust Fund) for Differently Abled Students

The Corporation has received online (through NHFDC website) total 3175 applications till 30th September, 2011. Hard copy of applications received in respect of 1269 candidates, which are being scrutinised.

b) Scholarship Scheme (National Fund) for the Students with Disabilities

The Corporation has received total 2646 no. of applications till 30th September, 2011 (i.e. the last date). 281 applications have been received after the due date upto 1st November, 2011. Online entry of applications is being done through an agency (by outsourcing the work).

CMD, NHFDC attended the meeting of working Group on 'Empowerment of PwDs' chaired by Secretary, S.J.&E at Vigyan Bhawan, New Delhi.
