

Sub: Major activities, decisions taken by NHFDC for the month of September, 2011.

With reference to the above, I am directed to furnish herewith following major activities/decisions in respect of NHFDC during September, 2011:

1. Annual General Meeting

Fourteenth (14th) Annual General Meeting (AGM) of the Corporation was held on 23.9.2011. Annual Accounts of the Corporation for the financial year 2010-11, report of Statutory Auditors, Directors' Report, Comments of C.&A.G. of India (Nil comment statement) were placed and adopted by members at the said Annual General Meeting.

2. Sanction and Disbursement of Loans

Particulars of loans sanctioned and disbursed by the Corporation during the month of September, 2011 are as under:

3. EDP Training for Persons with Disabilities

The Corporation sanctioned two (2) Entrepreneurial Development Programs for imparting training to 30 persons with disabilities for which Rs. 69477/- has been released by the Corporation.

The training was imparted through HCL at Dehradun (Uttarakhand) and Ahmedabad (Gujarat) for training on Tally Accounting programme.

4. Hindi Pakhwara

Hindi Pakhwara was organised in the Corporation from 14th September, 2011 (Hindi Diwas) to 28th September, 2011. The Pakhwara was inaugurated by Dy. General Manager, NHFDC on 14th September, 2011.

5. Participation of Beneficiaries in Exhibitions/PICs

a) Shilpotsav - 2011

NHFDC participated in Shilpotsav-2011 held at Dilli Haat, Opposite INA Market, New Delhi from 16th-30th September, 2011. 18 (eighteen) beneficiaries from 7 (seven) different states, sponsored by the Corporation participated in Shilpotsav-2011, exhibited and sold their products at Shilpotsav-2011. Total sale of Rs. 14,48,940/- was realised by the above NHFDC beneficiaries.

b) Workshop/Public Information Campaign (PIC)

Shri Arun Kumar, Asst. Manager (OL) of the Corporation participated in three days workshop (20.9.2011 to 22.9.2011) under Bharat Nirman Jan Suchna Abhiyan (भारत निर्माण जन सूचना अभियान) at Village Matanhel, Dist. Jhajjar (Haryana) for providing information of NHFDC schemes.

6. Inspection and Monitoring of NHFDC Schemes

a) Shri Anil Kumar, Chief Manager (P&A) visited Anand district of Gujarat from 5th to 10th September, 2011 and inspected 25 NHFDC beneficiaries there.

b) Shri R.P. Dubey, Asst. Manager (Personnel) visited Coimbatore (Tamil Nadu) from 15th to 17th September, 2011 and inspected 30 NHFDC beneficiaries there.

7. National Scholarship to Students with Disabilities 2011-12

As on 30th September, 2011 (the last date for receipt of applications for scholarship) about 2500 applications have been received by the Corporation for scholarship 2011-12 (National Fund).
