6. **SCHOLARSHIPS TO STUNDS WITH DISABILITIES**

Meeting of Scholarships Screening Committee (Trust Fund) was held on 04.0-9.2014 and decisions were made for sanction and release of scholarships for students with disabilities.

These are as follows:

- i) Sanction and release (Ex-post facto approval) of Scholarships to:
 - a. **546 Fresh** (463 Male and 83 Female) differently abled students involving aggregate amount of **Rs. 3,25,76,761/-** (Rupees Three crore twenty five lakh seventy six thousand seven hundred sixty one only) and
 - b. **104 Renewal** Scholarships involving aggregate amount **Rs. 72,43,542/-** (Rupees Seventy two lakh forty three thousand five hundred forty two only)

for the 3rd and 4th quarter (01.01.2014 to 30.06.2014). Aforesaid Scholarships are already released by NHFDC in the month of July and August, 2014.

- ii) Reimbursement of Course fee/balance course fee or/ and financial assistance for Assistive device to **82 students** aggregating to **Rs. 43,63,057/-** (Rupees forty three lakh sixty three thousand fifty seven only) whom scholarships were released in 1st, 2nd and 3rd quarter. The additional scholarships approved by SSC is to be release on receipt of funds from the Ministry.

7. **JOB FAIRS/PUBLIC INFORMATION CAMPAIGN**

During September, 2014, the Corporation participated in various camps/job fairs/Public Information Campaign and disseminated schemes of the corporation for the benefit of Persons with Disabilities.

8. COMPOSITE CAMPS

During the camp, Assistive Devices were distributed to **1195 PwDs. Letters for training** were issued for the training of **250 PwDs** under NHFDC scheme. CMD, NHFDC alongwith officials of the Corporation attended the aforesaid camp.
